9:08 President's Welcome – Bill Bowhill

- Winter Adcom goals: updates on 2024 progress, objectives for 2025, voting on all motions, focus on operational plans to deliver on goals, key deliverables for 2H25.
- Went through the org chart. Still working to fill the EDS society rep on our Adcom.
- Mentioned the retiring and rotating roles.
 - (VP Ed, TSE TC Chair, Region 8, Awards Committee, JSSC EiC, members at large)
- New members welcomed (for all of the above)
- Society status
 - Membership = 10k, stable, 2% of IEEE
 - What is total addressable membership (TAM) in our field → Likely >100k, thus we currently have about 10% of the TAM. Our membership fees are 2% of our revenue. A question was raised on what percentage of IEE members are not members of any society. Answer, about half.
 - Yearly surplus = \$300-\$500k
 - Reserves = \$16M
 - SCRC Take-away = society is in good health with resources available for more investment
 - Membership = strong, PSO, PUBS, EDU = solid, STDS = weak
- Vision/Mission, Field of Interest
 - Going to create ad-hoc on this topic.

- New ad-hocs (student, history, vision, awards)
 - Student led by Farshana = Forming team to develop proposal covering entire student experience and involvement, including budget. Report back in June for implementation in 2026.
 - History led by Bruce H. = curating history of our society and profession. Bruce discussed his goal to create a sense of "wonder".
 - Awards, led by Ken O, = working to set strategy, get more nominations, continuity, support services,
- IEEE SSCS a public charity
 - Discussed what this is and the goal to provide social good. Presented examples of public imperatives (where lot of our traditional activities are not public imperatives). Suggest that we should use around 10% of our surplus for public imperatives (\$50k)
- Inter-society collaboration
 - SSCS is in Division 1. (EDS, CAS, SSCS, Nano, CEDA). Can collaborate with these to promote the semiconductor industry.
- Dan proposed we should form another ad-hoc charged with defining the value proposition of membership and creating supporting materials.
- Suggestions raised, on awards to have some way to reduce the hurdle for nominators.

09:45 Conferences Committee Report -- Alessandro Piovaccari

- Deploying google drives for the five financial co-sponsored conference for long-term storage.
- Went through all the details of the tactical plan on lower left of quad chart.

- SSCL -- IF = 2.2.
